THE BASIS OF THE SECURITY SHOULD ALSO BE REDUCED BY 34.59% OF THE TOTAL DISTRIBUTION RECEIVED IN MARCH OF 2016.

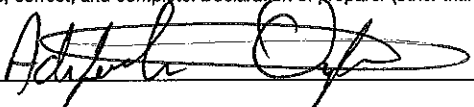
